DRAWS:

The Draw will be held at noon on December 30th, 2026, at the office of Stride Management Corp. 3950 -12 Street NE, Calgary Alberta. Only tickets received at the Lottery Ticket Sales Centre before 11:59 pm December 28th, 2026, will be eligible for this draw.

All draws are open to the public. Two member delegates of the Licensee will attend and witness the draw.

Prize draws follow a strict set of procedures, with draw control oversight by Stride Management Corp. and under licensing approval of the Alberta Gaming, Liquor and Cannabis (AGLC). Age limit for ticket purchasers is 18 years old and over. Purchase must be made in the province of Alberta. The Lottery draws are conducted using an RNG (Random Number Generator) system. The winning raffle draw number shall be determined from the pool of sold raffle ticket numbers. This will include all Early Bird draws and final draw.

Only upon demonstrating extraordinary circumstances to the AGLC will the Licensee make a request for a draw date extension.

Files are continuously backed up by Stride Management Corp. In the unexpected event of a power failure, the draw will be postponed and take place immediately once power has been restored.

ELIGIBILITY:

Raffle guidelines prohibit the following people from purchasing tickets: Employees of Stride Management Corp., their immediate family members, and anyone under the age of 18. Ticket purchasers must be 18 years of age or older, and the name of a minor must not be written on the ticket. If it is determined prior to the draw that a ticket has been issued to a minor, the ticket is deemed void and the purchaser refunded. Kinsmen Club of Coaldale as well as ticket sellers are eligible to purchase tickets.

PRIZES:

There is one prize for 50% of total ticket sales, to a maximum of \$1,050,000 cash

The Wild Hog 50/50 will guarantee a minimum prize of **\$50,000**. Minimum number of 4000 tickets must be sold before cutoff of the draw date before we apply for an extension or cancellation of the raffle.

Winner will be notified by representatives of the Kinsmen Club of Coaldale detailing what they have won and where they can claim their prize(s). The names, cities and winning ticket numbers will be published within 14 days following the draw on the lottery website at www.coaldalekinsmen.com/harley-raffle/.

Prizes must be accepted as awarded.

All prizes must be claimed within three months from the final draw date. If any prize(s) remains unclaimed for more than three (3) months from the date of the draw, a request will be made to the AGLC regarding the disbursement of the unclaimed prizes.

In the event a winning ticket stub lists more than one name, the licensed charity shall award the prize to only one of the individuals identified on the ticket, and the licensed charity and the AGLC are not responsible for any disputes which may arise between the different individuals.

TICKETS:

All sets of multiple tickets must contain the same information. All tickets will be controlled by Stride Management Corp. and are only available by phone, online, and at designated sales location or outlets identified by the committee as required.

Tickets may be purchased with VISA, MasterCard, Apple Pay, Google Pay & bank debit card. The Licensee's liability is limited to the purchase price of the ticket.

TICKET CONTROL PROCEDURES:

A Ticket Purchaser will be provided an E-Ticket, delivered to the Purchaser, through e-mail to the e-mail address provided and is delivered as a PDF (*Portable Document Format*).

The following summarizes the total number of ticket packages licensed and the manner in which the ticket numbers are assigned to a ticket regardless of the ticket delivery method.

We control ticket processing in the following manner. As per the sample tickets being sent to your office, there are 10,000 ticket sets printed as 5 ticket sets for \$25.00 (total tickets 10,000). The ticket number is assigned by the computer and printed with a leading alpha character "F". Next, there are 7,000 ticket sets; each set printed is 15 tickets for \$50.00 (total tickets 105,000). The ticket numbers are assigned by the computer and printed with a leading alpha character of "G". Next, there are 6,000 ticket sets; each set printed is 50 tickets for \$100.00 (total tickets 300,000). The ticket numbers are assigned by the computer and printed with a leading alpha character of "H". Finally, there are 6,000 ticket sets; each set printed is 100 tickets for \$150.00 (total tickets 600,000). The ticket numbers are assigned by the computer and printed with a leading alpha character "J".

For all tickets (E-tickets), the ERS generates an E-Ticket utilizing a high-volume e-mail protocol, an e-mail containing a pdf ticket is sent to the ticket buyer. The ticket numbers are assigned as outlined above.

From this point we verify that total tickets sold and printed equal funds received for any given day. Adam Parker, 50/50 Chairman - Kinsmen Club of Coaldale (403-394-6931), prior to any and all draws verifies all these processes and ensures the records are balanced with tickets sold and money received.

A sample of each of these tickets is attached - Total number of tickets printed is 1,055,000.

DRAWS:

Prize draws follow a strict set of procedures, with draw control oversight by Stride Management Corp. and under licensing approval by the licensing body, Alberta Gaming, Liquor and Cannabis (AGLC). Each prize draw will be conducted in accordance with the approved Raffle Terms and Conditions as put forth by AGLC.
